


FIRE SEASON

BRUSH AND FIRE HAZARD CLEARING

Spring has sprung, and so have all the plants, flowers, and weeds! Please make sure that you have taken appropriate precautions with your property before fire season arrives.

A defensible space of 100 feet around your home (Zone 2) is required by law, and is designed to protect the structure while providing a safe area for firefighters. Clearing an area of 30 feet immediately surrounding your home (Zone 1) is critical, and requires the greatest reduction in flammable vegetation. The recommendation for the remaining 70 feet depends on your vegetation and the



steepness of your property.

In July the FLEHA Board will be sending Fire Hazard letters to homeowners with visible fire maintenance issues, requesting immediate remedy.

APPROVAL OF JANUARY MINUTES: 4/0/0

TREASURER'S REPORT The account balance is 190K. This is approximately 10K more than at this time in 2016. ~\$41,000 in dues have been received.

COMMITTEE REPORTS

- Architectural Review: None in process.
- Park Committee: Skip Brown has offered to review and submit a request for bids for a rebuild of the community park tennis court. Bids will include pickle ball markings and a rebound wall which will have multi-use as a wall ball wall.

OLD BUSINESS

Website update: Website domain will be transferred to <u>info@fleha.org</u>. Website is generally in good shape. Each layer of the website is password protected. Suzanne Schroeder has been retained to transition the website and domain from the previous web designer and to make minor modifications to the website content

NEW BUSINESS

Update on dues: 15 dues are outstanding. A late letter will be issued and a motion to place liens on properties will be made at the March General Meeting.

Administrative position: The Administration position will be discussed in executive session.

Legal Review: Discussions were had with an attorney regarding compliance with David Stirling. The suggestion was made to change by-laws regarding election requirements in the event of number of candidates equaling number of positions.

System upgrade: A potential new homeowner would like to start a committee to investigate upgraded systems capability for internet service.

The meeting was adjourned at 7:46 pm, 4/0/0, with Executive Session immediately following.

OPEN FORUM/HOMEOWNER COMMENTS

- A resident informed us that several trees have died along the wall bordering the water treatment plant, leaving a 60
 -70 foot unscreened section. The exposed industrial buildings and lights are directly impacting residents at night.
 The resident agreed to contact the property owner, Roseville Water, regarding the issue before seeking Board input.
- The "internet improvement" committee proposed by a potential resident will not be formed due to a failed purchase contract. At this time, there is no additional interest in pursuing this committee.

APPROVAL OF FEBRUARY MINUTES: 5/0/0

TREASURER'S REPORT

The current balance stands at approximately \$203,000, which is approximately \$10,000 more than the same time last year. Year-to-date expenses are approximately \$5,000, leaving accounts in good standing. Taxes are due March 15. There will be a follow-up with the accountant to ensure that FLEHA either files on time or files for an extension.

COMMITTEE REPORTS

- Architectural Review: Nothing in process.
- **Park Committee**: The week of March 6 six bids were to be submitted for a rebuild of the tennis courts on behalf of FLEHA by Skip Brown, who currently serves as a road consultant for the state of California. He expects to receive bids within the next few weeks, and plans to schedule work for May/June. The work will include the addition of a rebound wall, pickle ball striping, and replacement of the basketball hoops.

OLD BUSINESS

Outstanding Dues: There are nine homeowners with delinquent dues. A list of names will be provided in an attempt to speak with the homeowners before initiating the lien process. Unless dues are paid before April 18, in the amount of \$275 (\$250 dues + 10% late fee), a certified letter informing them of a lien will be issued. At that time, fees are \$115.00 in addition to the \$275.00 balance. A motion was made and approved 5/0/0 to raise the lien fee to \$250.00 in 2018 to reflect actual costs. Formal notification will be made during the 2018 dues process.

NEW BUSINESS

- **Insurance Policies:** Two competitive insurance bids for Commercial Lines, Umbrella, Theft Endorsement, and Directors & Officers policies will be secured from Francis-Pinney Insurance Services and Rick Russo Insurance Company. All policies except D&O expire 4/19/2017. Once bids are received the Board will review and vote on the most competitive and complete bid provided. Sharon Russo will recuse herself from voting due to potential conflict.
- Update Bank Card: Board members will sign a new bank card with authorizing signatures at UMPQUA Bank.
- **Update Post Office Box Access**: The yearly update of Post Office Box access will be completed to grant access to the new Board members and Administrative Assistant.

BALLOT COUNT & ELECTION RESULTS

Two Board members were elected for 2-year terms: Chris Vadnais (re-elected for 3rd term, with 140 votes) and Sharon Russo (elected for first time, with 135 votes). The entire Board and all in attendance thanked Ozella ("Ozzie") Wasser for her eight years of service to our neighborhood association! The full Board membership is as follows:

TENNIS COURT REBUILD

Stay tuned! The tennis court rebuild is planned for summer of 2017. Bids are on target to go out the first week of April.

With all the rain this spring, it will take some time for the ground water to dissipate. The plan is to tear out the existing asphalt, remove tree roots causing bulging of the court surface, and install a root barrier. Courts will be paved and striped for tennis and pickle-ball, and new basketball hoops will be installed.

All should be ready in time to enjoy this year!
