Folsom Lake Estates Homeowners Association Board Meeting **January 16, 5:30pm** 6485 Oak Hill Drive, Granite Bay

IN ATTENDANCE

Board Members: Nicole Howe, Jennifer Makol, Marcie Shelton, Sharon Russo, and Chris Vadnais

Unit 2: Susan Moss, Bill Freeman, Jamie Crawford, Brian Mulrooney, and Olivia Roepke Unit 1: Maria and Walt Worthge

OPEN FORUM/HOMEOWNER COMMENTS: A member raised a concern about speeding on Oak Leaf near the park and inquired about having the HOA lower the speed limit to 15. Since the streets in FLE are county-owned, the speed limits cannot be changed without a county traffic study. A suggestion was also made to add "Caution: Children at Play" signs near the park. The Board will consider both suggestions in the next meeting. A member inquired about the HOA's budget and was directed to FLEHA's website to access that document. A member requested an explanation for this year's HOA dues increase; the Board reiterated the explanation that was provided with the HOA dues notifications and pointed out that FLEHA's dues are still lower than those in comparable Granite Bay communities. A member inquired if the HOA has plans to install lights in the park; the Board explained that there is no electricity in the park and adding it would be a very substantial expense. FLEHA has an agreement with the park next-door neighbor to utilize their electricity during events. A member expressed the desire for the HOA to implement stricter property maintenance requirements.

REVIEW OF APPROVED DECEMBER 2023 GENERAL MEETING MINUTES: No changes.

TREASURER'S REPORT: The year-end balance stands at approximately \$187,800, including \$122,185 in the Reserve Account, which puts FLEHA's reserves in a good financial position at 89.5% funded, per the most recent Reserve Study. The balance is approximately \$33,500 more than the same time last year. Expenses incurred since the December 2023 budget report were approximately \$3,300, leaving accounts in good standing.

COMMITTEE REPORTS:

Architectural Review: Items concerning specific homeowners to be discussed in Executive Session.

High-Speed Internet: No updates.

Park: The new broom and court roller squeegee have arrived and will be marked "Property of FLEHA" and added to the court shortly. If theft of these items continues, the Board may consider not replacing them.

OLD BUSINESS

Board Election 2024: FLEHA's newest Board member, Brian Mulrooney, will officially join the Board as of the March meeting.

Reserve Study/Annual Policy Statement: The final report will arrive shortly and will be posted online as part of the Annual Policy Statement.

Roseville Water Plant Property: Thanks to President Makol's letter campaign, the Roseville Parks Open Space Division has taken responsibility for managing the maintenance of the property. They have already removed two illegally dumped tree stumps and a damaged, fallen oak tree. They are currently removing dead bushes, shrubs, and trees, and pruning those that remain. They will also replant once weather permits.

Social Events: The first social event of 2024 is the Egg Hunt, which will be held on Saturday, March 16, at 2pm. Treasurer Shelton will purchase the pre-filled plastic eggs, and the following members volunteered to help during the event/with games: Walt Worthge; Olivia Roepke; and Jamie Crawford. A request for additional social event volunteers/social committee will be e-blasted on February 16 and included in the March-April newsletter. Dates were selected for the remainder of the social events, as follows: Car show/chili cookoff (5/17/24, setup at 4pm, event from 5p-7p); NNO/Food Trucks (8/6/24, 5-7pm); Concert in the Park/Taco Catering (9/21/24, 5-8p) – Members RSVP and receive wrist band to join the meal; FLEHA will provide desserts and drinks; BYOB; music will play during and after the meal; the search for a band will begin shortly.

HOA Dues: As of today, FLEHA has received 14 Unit 1 and 144 Unit 2 2024 HOA dues. At the same time last year, only 7 Unit 1 and 47 Unit 2 payments had been received. Member-at-Large Russo has received 12 requests for assistance with online payments. The Board agreed to review the outcome of requiring online payments once dues season ends.

Non-profit Status: Discussion postponed until the new Board term begins in March.

Recruitment: Treasurer Shelton and VP Howe will coordinate a volunteer recruitment event in the near future.

Dogs Off Leash: To be discussed in Executive Session.

Waterproof Bulletin Board for Park: The Board approved the purchase (approximately \$90) of a bulletin board for HOA notices, to be posted on the back of the park sign.

OPEN FORUM/HOMEOWNER COMMENTS:

Unit 2 resident Michael Wilson submitted an item (by email) for consideration. His concern regards the work trucks that frequently park on FLE streets in such as way that they block travel lanes and visibility. A notice will be included in an e-blast and newsletter reminding residents that their contractors must park off the street to ensure safe travel conditions.

Many FLE residents have expressed concerns, (e.g., increased traffic congestion; potential property devaluation; negative impact on the character of the community; strained school resources; etc.), about the proposed high-density residential rezoning on the corner of Fuller Drive and Auburn Folsom Boulevard. The Board welcomes the formation of a committee of FLE residents to track and engage with this issue and report back at monthly Board meetings. In the future, it might also be possible for a Board member to keep the neighborhood apprised of such community developments.

REVIEW OF APPROVED JANUARY 2024 GENERAL MEETING MINUTES: No changes.

TREASURER'S REPORT: The year-end balance stands at approximately \$232,600, including \$122,185 in the Reserve Account, which puts FLEHA's reserves in a good financial position at 89.5% funded, per the most recent Reserve Study. The balance is approximately \$32,000 more than the same time last year. Expenses incurred since the January 2024 budget report were approximately \$7,700, leaving accounts in good standing. Treasurer Shelton identified a CPA firm --Propp Christiansen Caniglia, LLP -- to handle FLEHA's tax returns. Their fee will be slightly higher than the previous firm, but they can also provide the Davis-Stirling review (\$800; required every two years). A motion was passed unanimously to transfer FLEHA's business to the new CPA firm. Shelton is also waiting on Chase Bank to provide information on potential investment options.

COMMITTEE REPORTS:

Architectural Review: Secretary Vadnais will investigate if a Unit 2 homeowner is building an addition outside of the required setbacks. Architectural plans for an ADU that were pre-approved by the Architectural Review Committee were submitted to and approved by the Board.

High-Speed Internet: Placer County Public Works has agreed on standards to be used by Astound for microtrenching in the county. The county awaits confirmation that Astound has received the trencher they ordered, so that project details and a timeline can be established. At some point soon, the county representative would like Astound to make a presentation about their project at an HOA meeting.

Park: The new broom and court roller squeegee are available on the sports court and the bulletin board is mounted on the back of the wooden park sign. Vadnais and park committee chairman Walt Worthge repaired a drain on the water fountain. Vadnais ordered the new tennis court net. Pickleball nets cost approximately \$100; the decision to purchase was deferred.

OLD BUSINESS

Roseville Water Plant Property: Nothing new to report.

Social Events: Egg Hunt, March 16, 2pm -- Shelton provided the game materials to the volunteers who will run them. All other logistics are handled. E-blasts about the event go out on 3/1, 3/9, and 3/15. Social Committee Recruitment -- A request for additional social event volunteers/social committee members was e-blasted on February 16 and will be included in the March-April newsletter. The Board will also set up a volunteer recruitment table at the Egg Hunt. Concert in the Park, September 21, 5-8pm -- The search for a band has begun, and the budget is \$1,500. Reaching out to volunteers to assist with the search. Taco catering is projected to cost approximately \$3,000.

NEW BUSINESS

HOA Dues: All 225 Unit 2 HOA dues were paid. Only four members had to pay late dues (\$385) this year. Payment breakdown: Unit 2 -- 202 paid online and 23 paid by check; Unit 1 -- 24 paid online and 3 paid by check. Expecting one more Unit 1 payment, for a total of 28 paid memberships. The Cheddar Up account was downgraded to a less expensive version until we begin accepting e-checks again in luminary season.

Future Board Meeting Dates: The next Board meeting will be held on March 19 at 6:30pm. The Board selected May 21 at 6:30pm and June 18 at 7:00pm for future meetings; locations TBA.

Potential Rule re: Property Upkeep in FLE Unit 2: To be reviewed during Executive Session.

Speeding on Oak Leaf near Park: Unit 1 resident Walt Worthge volunteered to spearhead the effort to have the county install "Caution: Children at Play" signs and lower the speed limit to 15 mph near the park.

Luminaries: Discussion of who will run the program was deferred to the March Board meeting.

The meeting was adjourned at 8:05pm, 5/0/0.

The Board held an Executive Session immediately after the general meeting.

<u>Leash Your Dog — It's the Law!</u>

Placer County ordinance (covered under County Code 6.08.010) dictates that if your dog is off your property, s/he must be "both leashed and under the handler's control". This means:

- Walking a dog off leash on the street is not allowed no exceptions!
 - Dogs off leash in a front yard must be physically prevented from greeting/charging/attacking others.

Traffic Safety Hazard Courtesy Notice: Work Vehicles Parked on FLE Streets, Blocking Travel & Visibility

The streets in our neighborhood are narrow and don't provide much shoulder space for parking, particularly for large trucks.

Recently there were some near accidents in FLE because several tree company trucks were blocking one side of the road, which impeded traffic and visibility, causing a safety hazard.

If you hire a contractor, please make every attempt to have them park their trucks in your driveway. If they must park in the street, then make sure that they are not blocking traffic lanes or visibility, especially on blind curves. If there is no way to prevent parked vehicles from blocking the roadway, then the contractors should use a flag person to direct traffic and place traffic cones in front of and behind their parked vehicles.

 Membership/Dues: Mandatory Unit 2 annual FLEHA membership dues are \$350, as of 2024. Unit 1 voluntary annual membership dues are \$140. Dues are due by Feb 1; a 10% late fee applies. A courtesy billing reminder is sent on Jan 1.

 Membership Benefits: Unit 2 members receive: one sports court key; option to reserve picnic grove and soccer field; copy of/inclusion in directory; FLEHA newsletter and free ad; email notifications; right to vote for and be a Board member. Unit 1 members receive the same benefits, but are not bound by Unit 2 CC&Rs, and therefore not allowed to vote for or be Board members.

 Board of Directors: Consists of five elected Unit 2 FLEHA members President, VP, Treasurer, Secretary, and Member-at-Large each serving a two-year term. Board members help ensure that our Bylaws are upheld, that our association is in compliance with Davis-Stirling HOA regulations, and that community concerns are addressed. Additionally, they maintain the park and the three neighborhood entrances, perform an architectural review process, and coordinate several annual social gatherings, including our December 24th luminary lighting.

 Board Elections: Held annually in January (ballots are mailed on January 1 along with dues notification). Only Unit 2 members are eligible to vote and run. Candidates who submit a "Notice of Desire to be a Candidate" form (available in November) by close of nominations on December 12 will be added to the ballot. Note: "If after the close of nominations, the number of qualified people nominated for election to the Board of Directors is equal to or less than the number of directors to be elected, then those nominees who are qualified to be elected to the Board are de


